

3D2N STAY IN HONG KONG DISNEYLAND 20TH ANNIVERSARY GIVEAWAY CONTEST

OFFICIAL RULES

Important: Please read these rules (“Official Rules”) before entering the 3D2N STAY IN HONG KONG DISNEYLAND 20TH ANNIVERSARY GIVEAWAY CONTEST (the “Contest”) to be conducted by The Walt Disney Company (Southeast Asia) Pte. Limited (“Disney”). By participating in the Contest, you agree to be bound by these Official Rules (and any amendments thereof) and represent and warrant that you satisfy all of the eligibility requirements set out herein below.

1. ELIGIBILITY

1.1. Entry to the Contest is open to all residents of Singapore, Malaysia and Thailand (each a “Market”) who are annual plan subscribers of Disney+ only. Participants must be above the age of majority in accordance with the applicable laws of their country of residence and should be aware that a breach of this requirement will result in the participant being disqualified (“Entrants”).

1.2. The Contest shall commence and end on the following dates (“Contest Period”):

Singapore, Malaysia: 00:00 hours (GMT +8) on February 16, 2026 until 23:59 hours (GMT +8) on March 16, 2026
Thailand: 00:00 hours (GMT +7) on February 16, 2026 until 23:59 hours (GMT +7) on March 16, 2026

1.3. Directors, officers and employees of Disney or its affiliated companies, subsidiaries, agents, professional advisors, advertising and promotional agencies, associate vendors and immediate families of each are not eligible to register for the Contest.

2. HOW AND WHEN TO ENTER

2.1. To enter the Contest, you must currently hold the following accounts, in accordance with your country of residence (“Account”): (i) a Disney account on <http://www.disneyplus.com/perksSG> (“Website”) for Entrants from Singapore; (ii) an Instagram account for Entrants from Malaysia; and (iii) send your Entry (defined below) via email to dci.disneyplusperksth@disney.com for Entrants from Thailand. Registering on the Website, Instagram or Facebook is free. After you have established your Account (if applicable), you may enter by doing all of the following: (a) sign in to your Account via the Website or, for Instagram and Facebook, via the mobile application on your smartphone or your desktop/laptop (“Application”); (b) answer the question below that will be posted on the Website and/or the following official accounts (“Official Account”): <https://www.instagram.com/disneyplusmy> for Malaysia, <https://www.facebook.com/DisneyPlusTH/> for Thailand; (c) submit your answer as prompted on the Website and/or via direct message (DM) to the Official Account or via email on the Application, as applicable (collectively “Entry”).

Question: In no more than 150 words, tell us why you would like to visit Hong Kong Disneyland.

2.2. You may not edit your Entry once it has been submitted. Failure to comply will result in the automatic disqualification of the Entry.

2.3. At the end of the Contest Period, one (1) Entry from each Market with the most creative answer to the Question will be selected as the overall winner for that Market (“Winner(s)"). The Winners will be contacted via DTCI.Disneyplusloyalty@disney.com with details on claiming their prize.

2.4. Disney has the right to, and shall select, the winning Entries for the Contest in its sole and absolute discretion and no correspondence and/or objection will be entertained. The factors Disney will take into account in selecting the Winner shall include, without limitation, the creativity and originality of the responses and such other factors as Disney deems appropriate in its sole and absolute discretion.

2.5. Entry by any person into the Contest will be taken as acceptance of these Official Rules. Entry by any method other than set forth in this Section 2 are void. Any use of automated or programmed methods of effecting Entry is prohibited.

2.6. The last Entry for the Contest must be submitted to the Website or Application or via email (as applicable) before 23:59 hours (GMT +8) on March 16, 2026 (for all Entrants) . Each Entrant is allowed to submit only one (1) Entry. In the event of more than one (1) Entry received from the same Entrant, the earliest entry by such Entrant shall qualify for the Contest. In the event that more than one (1) entry is received from an Entrant with similar personal particulars, then the earliest post from such Entrant shall qualify for the Contest.

2.7. Winner (and his/her companions, if applicable) shall complete a prize acceptance or release form prior to collection or enjoyment of his/her prize. Failure to satisfactorily complete and timely submit the required prize acceptance form will result in the disqualification of the Winner to claim the prize. In the event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed to be submitted by the person in whose name the Disney+ subscription is registered.

2.8. No personal data or anything offensive in nature should be featured in your Entry.

2.9. By participating in the Contest, each Entrant represents and warrants that he/she is not subject to any agreement or arrangement that would interfere with his/her participating in the Contest and is granting all the rights granted under these Official Rules.

2.10. Disney shall not be responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including but not limited to electronic malfunction or damage of any network, hardware or software. If for any reason the Contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest, Disney reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Contest. Disney shall decide in its absolute and sole discretion which submissions shall be included and posted on the Website or on the Official Account. No responsibility is assumed for: any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any e-mail or electronic entry to be received on account of technical problems or traffic congestion on the Internet or at any web site, or any combination thereof, including any injury or damage to any Entrant's or any other person's computer related to or resulting from participation in or downloading any materials from the Contest.

2.11. By entering the Contest, Entrants indemnify Disney, Instagram, Facebook and each of their respective parent companies, subsidiaries, affiliates, directors, officers, employees and agencies from and against any liability whatsoever, and waive any and all causes of action, related to any claims, costs, injuries, losses, or damages of any kind arising out of or in connection with the Contest. Entrant understands that this Contest is in no way sponsored, endorsed or administered by, or associated with, Instagram and/or Facebook.

3. PRIZE

3.1. The Winner will receive the following:

- One (1) x 2-night complimentary accommodation at Disney's Hollywood Hotel (with 20th Anniversary themed room) in Hong Kong
- Four (4) x 2-day Hong Kong Disneyland general admission park tickets

(collectively, the “**Prize**”). For the avoidance of doubt, flights, transportation to and from Hong Kong, and any other travel arrangements are not included in the Prize.

The Prize is valid for six (6) months from the expiry of the Contest Period (“**Validity Period**”) and is subject to terms and conditions as may be prescribed by Hongkong International Theme Parks Limited. Winners can redeem the Prize any time during the Validity Period except during the following block-out dates: April 3–6, 2026; May 1–4, 2026; June 19-20, 2026; and September 25–27, 2026.

The Prize shall not be sold or transferred for commercial use. All taxes associated with the receipt or use of the Prize is the sole responsibility of the Winner. The Prize is not redeemable for cash or transferable. No substitution allowed except that Disney may, at Disney’s sole discretion, substitute a prize of equal or greater value. The Prize cannot be used in conjunction with any other promotion or offer. The Prize will be awarded provided a sufficient number of eligible Entries are received and the Prize is validly claimed by May 10, 2026, after which no alternate winner will be selected, nor the unclaimed Prize awarded.

4.2. We may share your personal data with affiliates of the WDSEA Group or with other third parties for administrative and business purposes, or for cross-promotion. Third parties receiving your personal data will be bound by requirements under the Singapore Personal Data Protection Act 2012 (and any equivalent laws of Malaysia or Thailand in relation to your personal data).

In the event that a Dispute arises, you shall attempt first to resolve such Dispute by calling or chatting with customer support at <https://help.disneyplus.com/en-GB/contact-us> (Singapore), or writing into the customer support at MYhelp@disneyplus.com (Malaysia), or THhelp@disneyplus.com (Thailand), as applicable. If the Dispute is not resolved by following the customer support process within sixty (60) days from raising the Dispute to the customer support then either you or Disney may submit the Dispute to the Singapore International Arbitration Centre (“**SIAC**”) for final resolution by arbitration in Singapore in the English language in accordance with the Arbitration Rules of the SIAC in effect as of the date of arbitration, which rules are deemed to be incorporated by reference in this Section. Disney and you shall agree on a single arbitrator by agreement. In the event Disney and you cannot agree on an arbitrator within one month of commencement of the arbitration, a single arbitrator shall be appointed in accordance with the Arbitration Rules of the SIAC. The arbitral award shall be final and binding on Disney and you. You waive any defence of improper venue or inconvenient forum as to any action brought within Singapore.

9.3. These Official Rules are not intended to confer rights on any third party, whether pursuant to the Contracts (Rights of Third Parties) Act (Cap 53B) of Singapore or otherwise, and no third party shall have any right to enforce any provision of these Official Rules.
