

# **PREDATOR: BADLANDS GIVEAWAY**

## **TERMS AND CONDITIONS**

**Important:** Please read these terms and conditions (these “**Terms and Conditions**”) before participating in the Predator: Badlands Giveaway (the “**Giveaway**”) to be conducted by The Walt Disney Company (Southeast Asia) Pte. Limited (“**Disney**”). By participating in the Giveaway, you agree to be bound by these Terms and Conditions (and any amendments thereof) and represent and warrant that you satisfy all of the eligibility requirements set out herein below.

### **1. ELIGIBILITY**

1.1. Participation in the Giveaway is open to all residents of Singapore only. Participants must be over the age of 13 on the date of participation and seek parental consent should they be below the age of majority as per applicable laws (“**Participants**”). Participants should be aware that a breach of this consent requirement will result in the Participant being disqualified.

1.2. The Giveaway campaign shall commence on 6 November 2025 and end on 11 November 2025 (Singapore local time) (“**Campaign Period**”).

1.3. Directors, officers and employees of Disney or its affiliated companies, subsidiaries, agents, professional advisors, advertising and promotional agencies, associate vendors and immediate families of each are not eligible to participate in the Giveaway.

### **2. HOW AND WHEN TO ENTER**

2.1. To enter, Participants must have a Facebook or Instagram account (“**Account**”). Participants must also follow the Official Account. All dates, times, and locations listed below are subject to change or cancellation at Disney’s discretion without prior notice. 2.2. You must ensure that your Account is not set to "Private" so that your post can be viewed by the public during the Campaign Period.

2.3. Participation in the Giveaway and completion of all required steps set out in Section 2.1 will be deemed acceptance of these Terms and Conditions.

2.4. No personal data, major brands or logos, or anything offensive in nature should be displayed in your photo.

2.5. By participating in the Giveaway, each Participant (or parent / legal guardian of Participants under the age of majority as per applicable laws) represents and warrants that he/she is not subject to any agreement or arrangement

that would interfere with his/her participating in the Giveaway and is granting all the rights granted under these Terms and Conditions.

5.1.
